ORDINANCE No. 23-2010

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF
VALPARAISO AMENDING ORDINANCE NO. 16-2009 ENTITLED
“AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF
VALPARAISO ESTABLISHING CERTAIN GUIDELINES OF THE EAST GATE
PARKING AREA”**

WHEREAS, on July 27, 2009, the Common Council of the City of Valparaiso (“Common Council”), Indiana, adopted Ordinance No. 16-2009 entitled “An Ordinance of the Common Council of the City of Valparaiso Establishing Certain Guidelines of the East Gate Parking Area”; and

WHEREAS, Ordinance No. 16-2009 set forth certain parking regulations and a permit process for the East Gate Area; and

WHEREAS, the Common Council is desirous of further amending Ordinance No. 16-2006 to increase the cost of the annual permit fee.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Valparaiso, Indiana that certain sections of Ordinance No. 16-2006 shall be amended to read as follows:

5. Fees

(a) An initial administrative fee of Twenty-Five Dollars (\$25.00) and an annual permit fee of Two Hundred Dollars (\$200.00) shall be paid upon the issuance of a new permit.

(b) An annual permit renewal fee of Two Hundred Dollars (\$200.00) shall be paid thereafter for those permits which are renewed.

BE IT ORDAINED THAT, if any portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other portion or provision of this Ordinance.

BE IT FURTHER ORDAINED THAT, all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, re-established and confirmed.

This Ordinance shall be in full force and effect from and after its adoption and the procedures required by law.
