

**MINUTES OF THE MEETING OF THE BOARD OF PUBLIC WORKS & SAFETY  
VALPARAISO, INDIANA  
June 22, 2018**

The Board of Public Works & Safety of Valparaiso, Indiana met June 22, 2018, at 10:00 a.m. in City Hall. Present were Bill Oeding, Steve Poulos and Attorney Dave Hollenbeck. Bill Oeding called the meeting to order and Dave Hollenbeck led the Pledge of Allegiance.

Bill Oeding moved that the minutes of the June 8, 2018 meeting be approved, seconded by Steve Poulos and so approved.

Bill Oeding moved that the claims be approved for payment and subject to appropriation balances, seconded by Steve Poulos and so approved.

**Olthoff Homes/Froberg Road**

Nate McGinley requested approval of closing Froberg Road from Harrison Boulevard to Vale Park Road from July 9-20, 2018. This is for frontage improvements to Mistwood Subdivision and Pepper Cove Subdivision. Bill Oeding suggested they keep the road open evenings and weekends.

Bill Oeding moved to approve subject to opening the road evenings and weekends. Seconded by Steve Poulos and so approved.

**Traffic and Safety Recommendations**

Tim Burkman requested approval of:

No parking on the east side of Franklin 50' south of Elm;

At the South West corner of Lafayette and Indiana Ave to mark one space for "Drop Off Only" for County employees. Bill Oeding suggested this should be marked to be in effect during office hours of the County Building.

Post a sign on 325 East South of 30 "No Truck Traffic". This will be reconsidered when Montdale gets extended.

Bill Oeding moved to approve, seconded by Steve Poulos and so approved.

**Citizen Requests**

1. Request street closure for the Valparaiso Wine Festival on Saturday July 14 and Valpo Margarita Fest on Saturday, July 28. Street closure requested is Indiana Avenue from Lafayette to Napoleon. The block will be marked "No Parking" Friday night to accommodate early Saturday setup and will remain closed until the conclusion of each event. The Valparaiso Market will be moved to Lafayette Street on both event days between Lincolnway and Jefferson. The block will be closed from 6 am to approximately 3 pm

2. Approval for closure of city street and use of sidewalks on Saturday, August 4, 2018 for an Artisan Market from 10 am-4 pm
3. Request Approval for annual 4<sup>th</sup> of July Blast 5K Run/Walk taking place on Wednesday July 4, 2018 beginning at 8:30 am.
